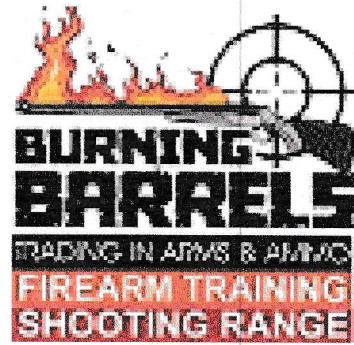

## PURPOSE STATEMENT – LAW

This manual is aligned with Unit Standard **117705** “Knowledge of the Firearms Control Act 60/2000.”

### PURPOSE OF THIS UNIT STANDARD

This unit standard is for persons who need to demonstrate knowledge of the Firearms Control Act 60/2000 (Act of 2000) that is applicable to legally possess a firearm.

- \* Demonstrate understanding of the stator duties and obligations of firearm ownership as contained in this Act;
- \* Demonstrate understanding of the statutory prescriptions applicable of the possession, handling, carrying, storage and use of firearms as prescribed by the Act; and
- \* Demonstrate understanding of the statutory prescriptions applicable to the possession and storage of ammunition as prescribed by the Act.

### LEARNING ASSUMED TO BE IN PLACE

Unit Standard **117705** needs to be the first Unit Standard that you must complete before you can add any of the Unit Standards for the Basic Handling and Use of the firearm categories: 119649, 119650, 119651 and 119652.

After this you can add the Business Purpose and/or the Range Office Unit Standards, but it must run in this order. For example, you cannot get Matric / Grade 12 until you have Grade 11.

- \* Communication NQF Level 2.

## **WHAT ARE UNIT STANDARDS?**

Unit Standards are building blocks of qualifications. Unit Standards are effectively a means of determining, not only what should be taught, but also what needs to be achieved by the learner. Therefore, Unit Standards are made-up of "Specific Outcomes". The specific outcomes explain what a learner must be able to achieve, in other words, what is the specific outcome achieved by the learner? We teach towards the Specific Outcomes of the Unit Standard and then we assess against the Specific Outcomes of the Unit Standard.

## **FURTHER COMPETENCY**

If you have already completed Unit Standard **117705** and have completed a firearm Unit Standard (for example – Handgun) and now you want to do the Shotgun Proficiency Training, then it is NOT necessary to re-do 117705, you can just add onto your already existing Unit Standards.
